5th meeting of Internal Quality Assurance Cell was held on 02.08.2014 at 10.30 A.M. at conference hall. The following members attended the meeting. The agenda is as follows:

The following points were discussed in the meeting.

- 5.1 Coordinator welcomed the gathering and presented the Annual Quality Assurance Report (AQAR) for the academic year 2013-14 among the members of IQAC. The members expressed their views about the backlogs in the report and suggested some ideas for improvement in preparing the AQAR for the next academic year.
- 5.2 Next, Coordinator briefed the agenda of the meeting to all the members.
- Dr.D.Manimegalai and Dr.B.Paramasivam suggested that the curriculum and syllabi of Regulation 2015 should be prepared as per the need of industries and feedback of alumnus. - Preparation of Bloom's -Spady-Assessment learning package is going to be introduced 5.6 to assess the course outcomes.
- Director advised the HOD's to organize atleast one Entrepreneurship development 5.7 programme in each department.
- 5.8 Alumni Expert Mr.Raghu Ramji suggested that entrepreneur programmes may be organized based on specific criteria like Venture capital funding, Mentorship, etc. He also suggested that, every year in achievement list the number of entrepreneurs produced may be earmarked.
- 5.9 For preparing plan of action for every year, each department may be requested to submit road map indicating academic performance, placement, research activities and student centric programmes.
