The Director welcomed all the members of the Governing Board. Afterwards he requested the principal to place the agenda items. The Principal presented agenda items one by one as detailed below:

AGENDA 38.01: TO CONFIRM THE MINUTES OF THE LAST MEETING OF THE GOVERNING BOARD HELD ON 05.08.2023

The Director of the college welcomed all the members and after that the Principal presented various academic and other important activities held in the college and approved the following proposals.

- To establish Artificial Intelligence Laboratory at the cost **Rs.40 Lakhs** for AI&DS department.
- To establish **TCS IOT lab** at the cost of **Rs.10 Lakhs** in the college campus for the benefit of students.
- To install 100KW DC roof top solar power plant at the cost of **Rs.55 Lakhs** in IT block roof top to augment the already available roof top solar power plants with 100KW capacity in CSE block roof top and S&H Block roof top.
- To setup e-learning centre in library for enabling the students to acquire knowledge, skills and training through digital resources and technologies at the approx. cost of **Rs.5 Lakhs**.
- To install 6 No's of interactive multimedia panels in the ICT smart class rooms of each department at the cost of **Rs.10 Lakhs**.
- To sanction seed money of **Rs.23 Lakhs** in total for the academic year 2023- 2024.To encourages faculty members to carry out research and product developments.

The minutes of the meeting held on 05.08.2023 was placed before the board and confirmed.

AGENDA 38.02: TO REPORT THE ACTION TAKEN ON THE MINUTES OF THE MEETING OF THE GOVERNING BOARD

- Artificial Intelligence Laboratory is established in B.Tech. (Artificial Intelligence and Data Science) department at the cost of Rs.40 Lakhs.
 - Installation 100KW DC of solar power plant in IT block has been completed and is ready for power generation.
 - E-learning centre in the library has been established.
 - Erection of multimedia panels in six class rooms in each department has been completed.
 - After securitizing the proposals received from the faculty members, the seed money of **Rs. 11, 50,000.00** has been granted as detailed below:
1. **Rs. 250000/-** to **Dr. R. Harichandran, Prof/Mech** for the project title “Evaluation of Heat Transfer Characteristics of Additive Manufactured Boron Nitride Nanotubes Dispersed AlSi10Mg Nanostructures”.
 2. **Rs. 900000/-** to **Dr.T. S. Arun Samuel. Prof/ECE** for the project title -“Modeling and simulation of Ferroelectric Vertical Tunnel Field Effect Transistors for Memory Devices”.

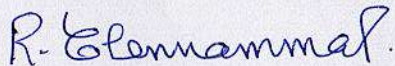
The Principal presented the resolutions and regulations passed in 20th meeting of academic council and board of studies.

It was resolved to approve the resolutions and regulations passed in the Seventeenth and eighteenth meetings of Academic Council (Annexure-VII).

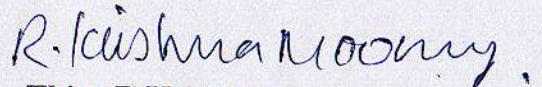
AGENDA 38.11: ANY OTHER MATTER

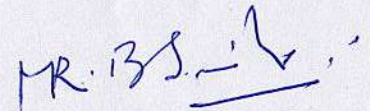
