Item No.16.2: TO CONSIDER AND APPROVE THE BUDGET ALLOTMENT FOR THE

FINANCIAL YEAR 2024-2025

The budget allotment for the financial year 2024-2025 was presented before the committee. It was finalized and the committee resolved to approve the same (Annexure-II)

Item No.16.3: TO CONSIDER AND APPROVE - REVIEW OF THE DEVELOPMENT ACTIVITIES

FOR THE FINANCIAL YEAR 2023-2024

The following Development activities have been presented for the financial year 2023 - 2024 in the last finance committee meeting held on 10.01.2024.

16.3.1 ROOF TOP SOLAR POWER PLANT

A 100KW DC / 80KW AC - Roof Top Solar Power Plant (TATA Power Solar) was established over the IT building roof top on a Turnkey Project. The total project cost was **Rs.55,00,608/-** in this year.

16.3.2. Digital Evaluation System in the End Semester Examination:

Digital Evaluation System worth of Rs.24,16,546/- was implemented during November 2022 End Semester Examinations with necessary software and hardware.

The Examination Tool and Digital Evaluation Tool (BET Plus) – additional features at the cost of **Rs.3,50,000/-** was purchased.

16.3.3 Seed money for R & D activities:

Startup idea proposals were invited for the 6th batch of NewGen IEDC Projects, and 51 proposals were received from the students across various departments. Seven proposals have been shortlisted for funding to encourage the faculty members and student members to carry out R & D activities and a pre-incubation fund of **Rs.4,71,350/-** was sanctioned for the year 2023-2024 and the projects are in progress.

Item No.16.4: TO CONSIDER AND APPROVE THE DEVELOPMENT ACTIVITIES FOR THE

FINANCIAL YEAR 2024-2025

The following Development activities are presented for the financial year 2024 - 2025.

- 16.4.1. To establish an IT Business Incubator at K.R. Innovation Centre an amount of Rs.51 Lakhs is sanctioned for this financial year 2024-25 and an amount of Rs.20 Lakhs is sanctioned to encourage startup entrepreneurs.
- 16.4.2. To establish a Computer Lab with Higher End Systems for the Artificial Intelligence & Data Science department an amount of Rs.37 Lakhs is sanctioned for this financial year 2024-25.
- 16.4.3. To establish an Internet of Things (IOT) Automation Lab to meet curriculum requirements and to provide the students with hands-on-experience in cutting at IOT technology an amount of Rs.10 Lakhs is sanctioned.

The committee considered the above proposals thoroughly and recommended it to Governing council for further approval. The Meeting concluded with vote of thanks by the principal.
